Complaint about mice and rats in classrooms and lunchroom.

**Violation: Noncritical - Failed items for Non-illness Complaint,410 IAC 7-24: 295 |  
Equipment food-contact surfaces, nonfood-contact surfaces, and utensils (noncritical)**

**Violation Description:** 1. Mice droppings on equipment and boxes in equipment storage room.  
2. Mice droppings on speedrack in walk in cooler.

(c) Nonfood-contact surfaces of equipment shall be kept free of an accumulation of: (1) dust; (2) dirt; (3) food residue; and (4) other debris; and shall be cleaned at a frequency necessary to preclude accumulation of soil residue.

**Corrective Action:** Keep clean as necessary.

**Violation: Noncritical - Failed items for Non-illness Complaint,410 IAC 7-24: 413 |  
Protected outer openings**

STATUS: OUT

**Violation Description:** Large gaps greater than 1/4" along bottom and middle of double doors.

(a) Except as specified in this section, outer openings of a retail food establishment shall be protected against the entry of insects and rodents by: (1) filling or closing holes and other gaps along floors, walls, and ceilings; (2) closed, tight-fitting windows; and (3) solid, self-closing, and tight-fitting doors. (b) Subsection (a) does not apply if a retail food establishment opens into: (1) a larger structure, such as a mall, airport, or office building; or (2) an attached structure, such as a porch; and the outer openings from the larger or attached structure are protected against the entry of insects and rodents. (c) External emergency exit doors that are: (1) solid and tight-fitting when closed; and (2) restricted from nonemergency use; do not need to have a self-closing device installed. (d) Except as specified in subsections (b) and (e), if the windows or doors of a retail food establishment, or of a larger structure within which a retail food establishment is located, are kept open for ventilation or other purposes or a temporary retail food establishment is not provided with windows and doors as specified under subsection (a), the openings shall be protected against the entry of insects and rodents by: (1) sixteen (16) mesh to one (1) inch screens; (2) properly designed and installed air curtains; or (3) other effective means. (e) Subsection (d) does not apply if flying insects and other pests are absent due to the location of: (1) the establishment; (2) the weather; or (3) other limiting conditions.

**Corrective Action:** Protect outer openings using approved methods.

**Violation: Critical - Failed items for Non-illness Complaint,410 IAC 7-24: 415 |  
Controlling pests**

**Violation Description:**

1. Mice droppings along cove base and on equipment/boxes in equipment storage room.
2. Mice droppings behind cooking/baking equipment throughout kitchen.
3. Mice droppings in laundry room behind washer/dryer.
4. Mice droppings on speedrack in walk in cooler.
5. Mice droppings along cove base throughout kitchen.
6. Mice droppings on floor behind unused equipment/old oven/cambros in corner of kitchen.
7. Mice droppings under/behind dishmachine and under 3 bay sink.
8. Mice droppings mop sink room/shelving located on far side of kitchen.

(a) The presence of insects, rodents, and other pests shall be controlled to minimize their presence on the premises by: (1) routinely inspecting incoming shipments of food and supplies; (2) routinely inspecting the premises for evidence of pests; (3) using methods, if pests are found, such as trapping devices or other means of pest control as specified under section 441, 449, or 450 of this rule; and (4) eliminating harborage conditions.

**Corrective Action:**

Control pests through integrated pest management.

**Inspection Comments**

Extensive cleaning has taken place since 02/27/2023 complaint inspection. Inspector did not note any mouse droppings where indicated in the complaint report or in other areas of the kitchen and storage rooms. Representative stated that all equipment has been cleaned and sanitized. Inspector noted that there were many people in the kitchen cleaning/sanitizing when re-inspection took place. Mice droppings have been cleaned from all floor-wall junctures throughout the kitchen and storage rooms. Equipment has been moved to get behind hard to reach areas. Only violation that remains is the gap along the bottom and middle of double doors just past the kitchen area. Pest control company has been called. Establishment is permitted to resume normal operation. Inspector will be back on Friday (3/3/2023) to follow up on remaining violation.

Violations noted on this inspection report could result in license suspension and/or legal action. You are entitled to an administrative hearing on this matter. A written request must be filed with the legal department, 3838 North Rural Street, Indianapolis, Indiana 46205, within 10 business days of the issuance of this notice.
