PROBABLE CAUSE: 1

ON TUESDAY MARCH 03, 2020 AT APPROXIMATELY 1240 **REDACTED**, MOTHER OF BRANDON HOLE, ACCOMPANIED BY BRANDON'S SISTER, **REDACTED**, ARRIVED AT INDIANAPOLIS METROPOLITAN POLICE DEPARTMENT'S, IMPD, EAST DISTRICT SEEKING ASSISTANCE WITH BRANDON HOLE. **REDACTED** STATED ON MONDAY MARCH 02, 2020 SHE DROVE BRANDON TO 'THE GUN BUNKER" LOCATED AT WASHINGTON AND POST TO LOOK AT GUNS. **REDACTED** WAS NOT AWARE THAT BRANDON POSSESSED MONEY TO PURCHASE A GUN; HOWEVER, HE BOUGHT A .410 SHOT GUN AND NO SHELLS. UPON ARRIVING HOME **REDACTED** AND **REDACTED** ASKED BRANDON WHAT HE WAS GOING TO DO WITH THE GUN. BRANDON BECAME ANGRY AND STRUCK HIS MOTHER WITH A CLOSED FIST IN THE ARM AND TOLD HER TO SHUT UP. **REDACTED** CONTINUED TO INQUIRE WHAT BRANDON PLANNED ON DOING WITH THE SHOTGUN AND HE REPLIED, "THIS IS NOT THE LIFE I WANT TO LIVE I'LL END IT MY WAY." FURTHER, "I AM GOING TO POINT THIS UNLOADED GUN AT THE POLICE AND THEY WILL SHOOT ME." **REDACTED** STATED BRANDON GETS VERY ANGRY AND SHE FEARS FOR HER SAFETY. **REDACTED** STATED SHE DID NOT GO TO WORK TODAY IN AN EFFORT TO SEEK HELP FOR BRANDON. **REDACTED** STATED BRANDON'S FATHER SUICIDED BY HANGING HIMSELF WHEN BRANDON WAS THREE YEARS OLD.

OFFICERS WENT TO **REDACTED** HOME WHERE BRANDON LIVES IN THE 1100 BLOCK OF HUBER. OFFICERS CHAPEL AND HUMPHREY, SERGEANT HEFFNER, AND DETECTIVE ROBINSON ARRIVED AT THEIR HOME WHERE **REDACTED** CALLED BRANDON DOWNSTAIRS. BRANDON UNAWARE OF THE POLICE PRESENCE CAME DOWNSTAIRS WHERE HE WAS SECURED WITHOUT INCIDENT. BRANDON UPON BEING PLACED IN HANDCUFFS BECAME IMMEDIATELY ANXIOUS AND STATED, "PLEASE JUST TURN THE POWER STRIP OFF ON MY COMPUTER." FURTHER, "I DON'T WANT ANYONE TO SEE WHAT'S ON IT." OFFICER HUMPHRY CLEARING THE UPSTAIRS AND SECURING THE SHOTGUN OBSERVED WHAT THROUGH HIS TRAINING AND EXPERIENCE INDICATED WAS WHITE SUPREMIST WEBSITES. BRANDON DOWNPLAYED ANY SUICIDAL THOUGHTS OR PLANS; HOWEVER, HE VOICED FEELING SAD AND DEPRESSED AND WOULD BENEFIT FROM COUNSELING. BRANDON HOLE WAS TRANSPORTED BY MCSD WAGON TO ESKENAZI HOSPITAL FOR FURTHER ASSESSMENT. SERGEANT VANEK IN CRIMINAL INTELLIGENCE WAS CONTACTED AND MADE AWARE OF THE CONTENT OBSERVED ON BRANDON HOLE'S COMPUTER. THE .410 MOSSBERG SHOTGUN WAS TRANSPORTED TO THE IMPD PROPERTY ROOM BY DETECTIVE ROBINSON WITH "SEIZED BY DANGEROUS PERSON" WRITTEN ON THE PROPERTY ROOM INVENTORY SHEET.
